Competition Director's Report

Dennis noted that the upcoming VMC meeting would be held in Monterey / Laguna Seca and mentioned some of the items on the proposed agenda. He would not be attending due to the expense.

CACC Vintage Discipline

Roger reported he would be attending the CACC meeting on Feb 18 and the AGM on March 13.

SCCBC Update

Reported by Stan and others;

- SCCBC AGM was last week; new President elected, Laurie Kaerne
- Year End Financials: No change in Driver Training revenue and General Revenue in 2015 over 2014., race registration revenue was up about 20% and track rental revenue was up about 50% (VRCBC take note), and they have over \$200K 'in the bank'.
- They have 60 events booked for 2016 already.
- Dennis mentioned that he had heard that BC Custom Car may be re-paving their shut down area (our front straight) probably in 2017
- Mazda Chase and Pace cars are back for 2016
- CACC is planning two cooperative events with the SCCA. One will likely be at The Ridge in the week prior to BCHMR
- SCCBC is planning grandstand upgrades. Mike noted that a group of volunteers will be needed to assist with the removal of the old grandstands and re-grading of the area to accommodate the replacements.
- SCCBC will likely purchase an on-site defibrillator.

- Many thanks to Gayle Baird for volunteering to take the CACC Stewards course. She will join our current team, Hugh Archer and Mike Bailey
- VRCBC Racing Car Eligibility & Approval Process for 2016 document presented for approval. Motion to approve, John Picard, seconded Paul Haym. Motion passed. Stan will present it to Roger for presentation / acceptance at the CACC Vintage Discipline meeting.
- March 23-27 Vancouver Auto Show on-line sign up available now. Need volunteers to setup, take down and man the booth for 2 hour stints. We will have visitor handouts, race schedules, membership forms and BCHMR promo materials.
- Ian Wood presented his proposed Club shirt. It was a 100% cotton golf style shirt, British racing green and would have a tasteful Club breast logo. Ian will get a quote for 50, following which we would look to pre-selling to members.
- A show of hands supported that no changes would be made to the REVS points criteria fro the upcoming 2016 season. A suggestion to collect points for winning and placing was rejected.

New Business

- The upcoming Tradex Car show conflicts with our April 12th race, so we are respectfully declining our usual booth. Ian Wood to communicate this to organizer. Suggestion to ask Karlo if he would volunteer one of his many cars for display will be followed up on.
- Roger re-tabled the suggestion regarding Two Day Race weekends. The thinking is that this would attract more out-of-town entrants. Some action items where tabled for Roger to follow up on.
- Wes tabled the value of joining NAACC, a lobby group of interested classic car clubs. More discussion to follow.
